IMPORTANT ENTRY INFORMATION • ACKNOWLEDGEMENT OF ENTRIES

Preliminary confirmation to be read, and corrections emailed to the Trial Secretary before the trial closes. Final confirmations to be emailed after the closing date. If you do not hear from the Trial Secretary that means they did not get your entry. It is the exhibitor's responsibility to contact the Trial Secretary either by email, mail, or phone to be sure of the status of your entry before any deadline dates passes. **The trial secretary is not responsible for entries not received on time, not received at all.**

NOTICE TO EXHIBITORS

ENTRY FEE: \$30.00 for the first entry of a dog and \$20.00 for each additional entry of the same dog (same trial Rally is not used as a second entry in combination with Obedience. (Includes AKC Event Service fee & AKC Recording Fee.)

CLOSING DATE for entries 6:00 PM, Wednesday, February 26, 2025, a wait list will be started when the numerical limit has been reached, if reached before Wednesday, Feb 26, 2025 (at Trial Secretary office) after which entries cannot be accepted, cancelled or substituted except as provided for in Chapter 11, Section 6 of the Dog Show Rules. A Wait List to be established if limits are reached before closing date.

RECORDING FEE of 50 cents for each dog, an AKC Event Service Fee of \$3.00 for the first entry of each dog and an AKC Event Service Fee of \$3.50 for each additional entry of the same dog will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. An AKC Recording fee of \$3.50 for each entry will be required for each dog in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 4) These Fees are paid to the American Kennel Club.

RETURNED CHECKS do not constitute a valid entry fee. TPDTCC will add a \$45.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

ENTRIES RECEIVED WITHOUT FEES will not be accepted. Electronic and unsigned entries cannot be accepted. Entries not on official AKC entry forms and photocopies of entry forms without the Agreement and Rules on the reverse side of the Official AKC Entry Form are not acceptable.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.

NO REFUND FOR DUPLICATE ENTRIES. We will make every effort to find all duplicate entries, but if a dog has been processed, no refund will be made.

Refund and Cash award checks are void after 180 days and will NOT be re-issued.

ERRORS ON ENTRY BLANKS. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

Trial Secretary will make every effort to decipher illegible handwriting but is not responsible for errors due to illegible writing.

ENTRY FEES shall not be refunded if a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made after closing date.

BITCHES IN SEASON. Since bitches in season are not permitted to compete in Obedience Trials, all but \$5.00 of the entry fee for bitches unable to compete for that reason, will be refunded. To be eligible for such refund the Trial Secretary must be notified in writing ½ hour or earlier prior to start of first class of the trial together with a veterinarian's certificate on their letterhead confirming the fact that the bitch is in season.

CONSULT JUDGING PROGRAM FOR TIME OF JUDGING. All dogs should arrive 15 minutes before judging time. Judges will not wait for any dog holding up a class. Dogs will be judged in catalog order. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when requested.

THE SHOW COMMITTEE will use care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability, in the event of an accident or misfortune to either dogs or exhibitors participating in the show.

THE OBEDIENCE TRIAL AND RALLY TRIAL will be open from 7:00 A.M. to ½ hour after trial ends.

DECLINATION OF ENTRIES/REMOVAL OF DOG: The trial committee may refuse to admit or may remove any dog on account of disease, viciousness, or other causes, and no one shall have any claim or recourse against the trial-giving club or any official thereof. All dogs must be on leash or confined to a crate except when being judged.

DIRECTIONS TO THE TRIAL

From the South: I-35 to Midway Road; Midway Road to Hwy I-94 Cross Hwy 53 to Lindahl Road (look for Casa Latte Restaurant); continue on Lindahl Road 2 miles. Building is on the right.

From the Iron Range: Hwy 53 south to past Pike Lake to Lindahl Road (Casa Latte Restaurant will be on the left); turn left on Lindahl Road; continue 2 miles to building on the right,

From Superior, WI: Take the Richard I Bong Bridge; keep on 46th Ave W and turn right onto Grand Ave. Turn left onto 40th Ave W and continue on Haines Rd. Continue up the hill toward Hwy 53. At the fourth set of traffic lights, turn left on Hwy 53. Continue on Hwy 53 to Lindahl Road (about 2.4 miles); turn right on Lindahl Road (Casa Latte Restaurant is on the right, on the corner); continue on Lindahl Road 2 miles. Building is on the right.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time the entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of the acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rule refer to Chapter 11, Section3).
- Mixed Breed Dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
